She was responsible for developing Performance Assessment Frameworks and quality assuring annual Aid Program Performance Reports for Afghanistan and Pakistan. She was also responsible (with her job share partner) for designing and implementing an innovative approach to remote monitoring and risk management for the Afghanistan aid program, the M&E Lab. This body of work, funded by DFAT's InnovationXchange (iXc), included trialing adaptive management approaches and big data approaches for M&E in conflict zones. Ulla's work was
