Milena is an evaluation specialist with 15 years expertise in natural resource management, sustainable agriculture, and environmental conservation in the areas of policy development, program design and evaluation. She has been involved in complex programs from climate adaptation in the Mekong River basin to water quality improvement in the Great Barrier Reef. Former Associate Director of Water Quality at the Great Barrier Reef Foundation, she contributed to the program design and developed and implemented MEL frameworks for multi-million-dollar programs, including the \$200M Reef Trust Partnership Water Quality program (2019-2025).

Working in Queensland since 2010, Milena holds deep familiarity with the complexities of agriculture and how these may affect program delivery. Her hands-on experience spans roles across diverse organisational contexts including state government, NRM organisations, agricultural industry bodies, and non-profit organisations. This multi-perspective experience enables her to navigate complex stakeholder relationships and understand varied institutional drivers.

Milena is an experienced manager and evaluator of large-scale complex programs, including:

Designed and implemented the Monitoring Evaluation and Learning framework for the program, using a combination of models and biophysical measurements alongside qualitative methods to demonstrate water quality improvements and understand farmer behaviour change.
- Grazing Resilience and Sustainable Solutions (GRASS) program evaluation for the Reef Water Quality Program, Office of the Great Barrier Reef (2024 – 2025) with the Alluvium Group. Contributed to the design, implementation and analysis of the end of program evaluation of GRASS 1 and mid-term evaluation of GRASS 2.

Planned and co-facilitated consultation workshops with diverse participants from governments, NGOs, community groups and financial institutions across Southeast Asian countries around issues relevant to climate change adaptation policy.
